## Compliance+

Risk associated with driving is often looked at in silos - licences are checked, telematics systems are installed, end of contract wear and tear charges are passed on and policies are written and circulated. And although all of these things are necessary and important, essential in fact, is anyone putting all these things together to look at the bigger picture?



Viewing these things in isolation means things could slip through the net.

It's only by putting all the pieces of the puzzle together that you can see the true picture.

TMC take a positive and preventative approach to risk.

Our proactive service is all about improving safety and reducing costs.

We do this by aggregating and interrogating all of your driver data to gain a complete view of driver behaviour.

We can take feeds from your telematics, fuel card and insurance providers and overlay it with feeds from your leasing company(s) data, mileage and duty of care data to create a 360-degree view of each driver.

From your telematics data we can identify dangerous driving styles and highlight drivers doing lots of trips between 2pm and 4pm – an incident hot spot. Or flag drivers doing lots of short journeys.

We can take insurance data to see who has made claims.

Data from your leasing company enables us to identify who has had significant wear and tear on their company vehicles and who has received fines.

We can overlay all of this with mileage and driving licence points to identify any high-risk drivers and act to prevent incidents.

Our expert auditors are also on hand to collate and verify your employees' documentation; including driving licence checks and for grey fleet drivers, insurance, MOT and vehicle safety checks.

We will contact drivers directly where we spot any risks or behaviour that needs addressing. We will discuss how they can make changes to improve their safety/driving style.

You'll receive in-depth management information, giving you total visibility. You will also have a complete record of all the checks that have been made.

## Preventative, inclusive comprehensive risk management.

We have designed Compliance+ to be completely -flexible, so we can work with the data you have and fill in any gaps with our services and in-house team, if required.

The first step is to identify who drives on business. This will ensure that everyone who drives on business, whether that be in a company vehicle or their own vehicle, is identified.

We will assess what data you already have available. There is no limit to the number of data feeds we take - if you have multiple telematics suppliers, we can take data from all of them.

In addition to the data feeds, we can help with:

Policy - Establishing a formal policy will help to clarify responsibilities and ensure that everybody affected knows what is expected. The policy could include safety guidelines and codes of conduct for employees. TMC can assist you with this and ensure the policy is being enforced. For example, are employees abiding by rules on maximum driving times? We can check the actual time behind the wheel via your telematics data.

**Driving licence checks** - are essential for everyone who drives on business. Our instant DVLA licence check verifies individuals' driving licence details including vehicle eligibility and penalty points. We can flexibly recheck drivers in line with the number of points they have to actively manage higher risk drivers.

Vehicle Safety Checks - A key element of duty of care is to ensure that all vehicles, whether company-owned or grey fleet, are safe to drive at all times. Because grey fleet maintenance is outside the company's control, vehicle safety could be compromised. Checks should be put in place to ensure compliance with safety ratings and maintenance records. We can do this for you and provide an auditable record demonstrating that every vehicle within your fleet has been subjected to regular safety checks. At intervals specified by your fleet policy, drivers will be required to log onto the TMC system and complete a declaration that they have checked their vehicle's tyres, wipers, lights, etc. as required. With our mobile app, they can also scan in images of their vehicle. TMC will review this data and ensure compliance.

**Grey fleet documentation** - we can check insurance documents to ensure drivers are covered for business use. We can also check MOT documents. We will chase drivers who haven't supplied up to date or satisfactory documents. We can even check whether drivers have had an eye test within the last couple of years.

**Driver Training** – Where risks are identified with driving behaviour, either from the various data sources gathered or from an online risk assessment check completed by the driver, we can help you with driver training. The majority of which is accommodated by on-line training modules. Medium Risk drivers will often receive two or three on-line modules appropriate to the risks identified. High risk drivers may sit an on-line Hazard Perception Evaluation Test or attend an on the road course with an instructor.

Our comprehensive and proactive service is designed to look at all the factors that feed into risk and take corrective action by contacting drivers directly to discuss their behaviour. We ensure you have all the information you need to reduce driver risk and ensure the safety of your employees.
